Remote Control

MAPLight.org is a nonpartisan, nonprofit research group illuminating the connection between money and politics. In this study, we examined all campaign contributions given to members of the California Assembly and Senate since January 2007 to determine the geographic sources of contributions to each legislator. We found that 79% of campaign contributions came from outside of members' districts. In other words, California lawmakers raised almost four out of every five dollars in campaign funds from outside of where their constituents live.

In generating this report, MAPLight.org analyzed contribution data provided by the National Institute on Money in State Politics.

Funds Raised from Out-of-District

California legislators raised \$97.9 million in campaign funds during this three year time period. \$77.5 million of these funds, or 79%, came from out-of-district. \$11.9 million, or 12%, came from in-district. The remaining \$8.5 million of campaign funds (9%) could not be definitively located as in-district or out-of-district.

This study includes reported contributions from January 1, 2007 through March 17, 2010 to campaign committees for Assembly and state Senate, excluding contributions to campaigns to other offices (e.g., Lieutenant Governor, U.S. House) and also excluding contributions from political parties and candidates.

To our knowledge, this study is the first ever to examine the geographic sources of campaign funds for California legislators using street-address level of detail to determine whether contributions originated from in-district or out-of-district.

We examined contributions given to 79 Assembly members and 40 Senators: all legislators who were serving as of August 31, 2009. Assembly District 51 was vacant on that date. (Two of these Senators, Denise Moreno Ducheny and Roy Ashburn, who are both now term-limited, did not raise any money after 2006.)

More than half of the lawmakers (58%) raised 80% or more of their campaign funds from outside their districts (68 out of the 117 members that raised money during this time period). Nineteen lawmakers raised 90% or more of their campaign funds from outside their districts.

Every lawmaker raised more than half of their funds from out-of-district. In other words, no lawmakers raised most of their money from in-district, where their constituents live.

The average percentage of funds each lawmaker raised from out-of-district is 79.2% and the median percentage is 82.5%. For out-of-district contributions figures for each lawmaker, see Table 1.

All 117 lawmakers had at least one Sacramento ZIP code among their top 10 contributing ZIP codes. For the top 10 ZIP codes for each lawmaker, see Table 8.

Individuals and Organizations

Lawmakers received most of their money from organizations: businesses (ranging from corporations to sole proprietorships), trade associations, political action committees (PACs), and unions. 85.1% of contributions from organizations came from out-of-district.

Less than 20% of contributions came from individuals. 51.8% of contributions from individuals came from out-of-district. Table 4 shows, for each legislator, the breakdown of out-of-district contributions from individuals and organizations.

Campaign contribution reports filed with the Secretary State indicate whether a contributor came from an individual's personal funds or is "other," defined as "business entities and other contributions." We interpreted this "other" category as organizations.

Methodology

This study includes reported contributions from January 1, 2007 through March 17, 2010 to campaign committees for Assembly and state Senate, excluding contributions to campaigns to other offices (e.g., Lieutenant Governor, U.S. House) and also excluding contributions from political parties and candidates. We used campaign contribution data from the National Institute on Money in State Politics as of April 29, 2010, whose data is based on reports that candidates and contributors are required to file with the California Secretary of State.

We examined contributions given to 79 Assembly members and 40 Senators: all legislators who were serving as of August 31, 2009. Some notes about how this date range affects certain legislators:

- Asm. Felipe Fuentes, who took office May 25, 2007, is included.
- Asm. Warren T. Furutani, who took office February 7, 2008, is included.
- Sen. Curren D. Price, Jr., who represented AD-51 until moving to the Senate on June 8, 2009, is included.
- Asm. Michael Duvall, who left office September 9, 2009, is included.
- Asm. Steven Bradford, who took office September 10, 2009, is excluded.
- Sen. John J. Benoit, who left office November 30, 2009, is included.
- Asm. Paul Krekorian, who left office January 5, 2010, is included.
- Asm. Chris Norby, who took office January 29, 2010, is excluded.
- Sen. Abel Maldonado, who left office April 27, 2010, is included.
- Sen. Denise Moreno Ducheny, who is term-limited, did not raise money after 2006 and is excluded from calculating percentages.
- Sen. Roy Ashburn, who is term-limited, did not raise money after 2006 and is excluded from calculating percentages.

We determine whether the contributor was out of district based on whether the address of the contributor was in the district for which the candidate was running. For example, if an Assemblymember was running for re-election, we analyzed the boundaries of the Assembly district for all contributions to their campaigns. If a 2009 Assemblymember was running for Senate in the 2010 cycle, we analyzed the boundaries of the Assembly district for their Assembly campaign (contributions for 2007-2008 election cycle) and the boundaries of the Senate district for their Senate campaign (contributions for 2009-2010 election cycle).

Address Geolocation

Candidates are required to report to the California Secretary of State the address for each contributor who donates \$100 or more. For amounts under \$100, campaigns often report these contributions grouped together as “unitemized,” with no addresses reported (Campaigns do sometimes report the address for some under-\$100 contributions). We used the available address data to determine the state Assembly and state Senate district of each contributor. To geographically locate each of the contributions, we used the services of Azavea Inc., a software development firm specializing in mapping solutions that employ Geographic Information Systems (GIS).

To our knowledge, this study is the first ever to examine the geographic sources of campaign funds for California legislators using street-address level of detail to determine whether contributions originated from in-district or out-of-district.

For 91.3% of total dollars contributed, the address information reported was sufficient to determine whether the contribution was in-district or out-of-district. For the remaining 8.7%, we could not determine the exact district location. These cases occurred because of one or both of these reasons:

- The address reported by the candidate campaign committee was not a valid address.
- Azavea’s street address mapping system was not 100% certain the location was within a particular district. For these cases, if the address was reported to be outside of California, we assigned these as out-of-district. Otherwise, we assigned these contributions the “district unknown” category.

Contributions Excluded

We intentionally excluded contributions from political parties because these contributions do not have a clear location of origin – it would not make sense to allocate them to a particular geographic place. We similarly excluded contributions from candidates because they do not come from a clear geographic place.

The data set we used, from the National Institute on Money in State Politics, omits a small portion of contributions which candidate committees report to the Secretary of State, specifically:

- Contributions to campaign committees for races where the candidates hasn’t officially registered to run. For example, Assemblymembers who have received contributions in 2009 and early 2010 in preparation for a 2012 state Senate campaign are not included since it is not yet possible to officially register for a 2012 campaign.
- Contributions to campaigns run during a special election.
- Contributions not filed electronically (for the 2010 cycle).
